### Stallholder Information

- TRADING DAYS** Every Sunday
- TRADING TIMES:** 8am – 2pm
- SET UP TIMES:** 7.00 am – 8.00 am.
- PACK UP TIMES:** 2.00 pm – 3.00 pm.
- 
- LOCATION:** Located in the Manly CBD, the Market is at Sydney Road and Short Street Plaza.
- 
- STALL FEES:** **CASUALS** - \$130.00 (incl. GST)  
**REGULARS** - \$125.00 (incl. GST)
- INSURANCE:** All Stallholders must have their own public and product liability insurance with a minimum of \$10 Million cover in the Stallholder's Name.
- A copy of the Insurance Certificate of Currency must be supplied to the Manager before a Stallholder may trade at the Market. It is the responsibility of the Stallholder to ensure that the insurance is renewed and remains current for the term that the Stallholder sells products at the Market.
- 
- POWER:** Power is available on request.
- Charges per Market: 10amp point = \$6.00 15amp point = \$11.00
-

- EQUIPMENT:** Stallholders must bring their own equipment. Please ensure that all tables have a suitable cover reaching within 10mm from the ground.

- VEHICLE**
- DROP OFFS:** Loading zones are located at Whistler St, Central Ave and at Short Street. Stallholders with special set up requirements should email our office.
- 
- FINDING YOUR**
- STALL:** Market staff will be located at the Sydney Rd.

## **PRODUCE MARKETS**

**WHERE TO PARK** Paid parking is available in one of 3 car parks within 500 metres of the Market. Special parking arrangements have been made for **OVERSIZED VEHICLES** that cannot use car parks. Our staff will advise on arrangements for trucks and high vehicles on Market Day.

**NOTE ON SET UP AND VEHICLES:** When **UNLOADING**, it is absolutely essential that you unload your vehicle and take the car off the area **BEFORE** you set up your stall.

### **FLOOR**

**COVERS:** All hot food/ready to eat food traders must bring floor covers. Some points to remember when selecting your floor covers;

- It must cover the entire cooking and food prep area of your stall preferably 3m x 3m
- Liquids do not easily leak through it

If you don't bring appropriate floor covers, you will not be allowed to trade. Stallholders may also be asked to cover any costs incurred as a result of cleaning their stall area.

### **WASTE**

**REMOVAL:** Garbage bins are provided for waste generated by the public not by Stallholders. You must take your waste and packaging back with you.

**PACKAGING:** In accordance with Manly Council Policy all packaging and bags must be made of biodegradable or recyclable materials. Plastic products are not accepted and traders that are using them will be asked to remove them.
